



2020 TOXIC CHEER & STUDIO X DANCE TERMS AND CONDITIONS/WAIVER

1. Students are required to follow the school's uniform and conduct regulations, including being well groomed and arriving on time for classes.
2. Due care will be taken with your child while they are in classes, however in case of illness or injury, where parents are not contactable, we will seek medical advice and act accordingly. Where treatment is deemed necessary all costs will be incurred by the parent/guardian.
3. Toxic Cheer (TC) and Studio X Dance Company (SXDC) take no responsibility for loss or damage to personal property.
4. I agree to attend all rehearsals, except in the case of illness/injury.
5. Hire costumes provided by TC and/or SXDC remain the property of the school and may be hired by pupils at the Director's discretion.
6. I understand that no uniform issued by TC and/or SXDC will be worn by any person in an establishment that does not allow entry to any child under the age of 18 yrs.
7. I undertake to pay all fees as they are due for payment, for any period which the above student is enrolled at TC and/or SXDCS.
8. I will read all TC and/or SXDC Term Newsletters, Information Booklet and email communication and respond respectfully.
9. I will treat all staff and members of TC and SXDC with respect and appreciate their experience and knowledge as teachers and trained professionals.
10. I agree to maintain a positive atmosphere for all students and community members by refraining from making negative comments about the school, teaching staff, processes, choreography, costuming etc. or about other students at any time.
11. I will not dispute class placement and respect that all placements have been derived from many years of teaching experience and many factors have been considered when placement selection occurs.
12. I agree my role as a 'cheer' and/or 'dance' parent is to support my child. I also agree that my role as a 'cheer' and/or 'dance' parent is to support our school, each other, our faculty and our Director/Principal/Head Coach. I will acknowledge each decision is made with good intent and is in the best interests of my child.
13. There is an expectation that all students, regardless of where they are (training or at competition) will behave respectfully towards teachers, other students and schools/clubs. Bad sportsmanship will not be tolerated. If a student behaves badly, we will retract their ability to perform at the next competition and competition fees will not be reimbursed.
14. I will use and promote all TC and/or SXDC social media accounts appropriately and respectfully and I understand that TC and/or SXDC reserve the right to block or ban me or my family from their pages.
15. I will provide two weeks' notice if I choose to leave TC and/or SXDC with the understanding that if I am an elite student my direct debit payments are a 48 week commitment and continue for the remainder owed.
16. I agree to my child being photographed or filmed for the program. This includes the right to photograph and film myself/child during lesson, events or performances and to publish in media such as websites, flyers, Facebook, posters, newspapers and videos snapchat and You Tube, but not limited to just those listed.
17. TC and/or SXDC must be notified of any arrangements relating to custodial agreements.
18. Please communicate with the Director/Principal/Head Coach regarding your child/ren taking regular medication and what this is for. Any changes to the above must be communicated to the Director/Principal/Head Coach or any member of our administration staff. Please notify us of any medical conditions that could affect your child's behaviour and ability to participate in class.
19. TC and SXDC follows strict procedures in relation to safe administering of medication.
20. All competition entries will be administered via TC and/or SXDC including dance solo performances. As students are representing our school, we need to monitor class attendance in order to approve each competition as it arises. Students who do not attend all elite classes as described in the 2020 Information Booklet will not be eligible to perform. If competition fees have been paid in advance and a student is not allowed to perform due to non-attendance or bad behavior, their entry fees will not be reimbursed. – Students who do not have weekly privates will not be eligible to perform solos.
21. SXDC supports solo students to enter as many competitions as they would like to however if team classes/rehearsals/performances have been organised (even at the last minute) and these times happen to crossover the solo competition dates/times, the student is expected to attend the team event - no exceptions. We will do our best to give as much notice as possible but ask people do not approach us with requests for different group training/event times as a result of solo competition crossovers.
22. As a security measure, TC and SXDC have installed security cameras around its premises. Your child/ren will be under surveillance during their practice hours within our Port Kennedy, Bellevue and Bunbury facilities.

Medical/Accident

I understand as a parent /Guardian athlete named below & hereby give permission for my child to attend and actively participate in any TC and/or SXDC lesson, event or performances throughout 2020. I understand by attending and participating in the above mentioned there may be risk of injury and or physical illness to an athlete which I waiver and release and forever discharge any and all rights of claims for damages which may arise now or in the future against Toxic Cheer and/or Studio X Dance Company Directors/s, Staff, Contractors or any other associated representative of Toxic Cheer and/or Studio X Dance Company – Cheer and Dance Pty Ltd. Furthermore, I authorise the director/s of Toxic Cheer and/or Studio X Dance Company to act for me and on behalf of me in any emergency requiring medical attention.

I have read the 2020 TC and/or SXDC Terms and Conditions and respective information booklets in their entirety and have a full understanding of the contents.

I agree if I have not entered a payment plan, full payment of invoices is to be made within 14 days. I understand late payment may result in a \$35.00 late fee and my child/ren's removal from the program. If my invoices are forwarded to a Debt Collection Agency, I shall be liable for ALL collection costs incurred. All fees (unless arranged prior) will be deducted via direct debit. All dishonour fees and charges will be the responsibility of the account holder.

I understand that when myself/my child are representing TC and/or SXDC we must always conduct ourselves within the guidelines of our Terms and Conditions. I understand that if any parent or athlete that does not abide by the rules and regulations contained in this contract and the rules outlined in the 2020 TC and/or SXDC Information Booklet, that is consistently negative, or acts in a manner that jeopardizes the name and or reputation of TC and/or SXDC, will be subject to removal without refund.
